NOTES:

- (1) This is not an exhaustive list and only summarizes IATA Dangerous Goods Regulations (DGR). Shippers should note that IATA DGR publishes many State and Operator variations and there may be additional regulatory controls such as ICAO and national hazardous material regulations.
- (2) Shipments of loosely packed cells that exceed the package limitations of Packing Instruction 968, Section II must be shipped under Packing Instruction 968, Section IB as Class 9 Dangerous Goods. Limitations: Passenger aircraft = Forbidden. Cargo only aircraft = 2.5kg net weight per package.
- (3) Shipments of loosely packed batteries that exceed the package limitations of Packing Instruction 968, Section II must be shipped under Packing Instruction 968, Section IB as Class 9 Dangerous Goods. Limitations: Passenger aircraft = Forbidden. Cargo only aircraft = 2.5kg net weight per package.
- (4) Batteries must be shipped with a maximum state of charge of 30%.
- (5) Shipments of loosely packed batteries that exceed the package limitations of Packing Instruction 965, Section II must be shipped under Packing Instruction 965, Section IB as Class 9 Dangerous Goods. Limitations: Passenger aircraft = forbidden. Cargo only aircraft = 10kg net weight per package.
